Articles of Incorporation
Of a Tax-Exempt Corporation

Pursuant to A.R.S. 10-3202

The 57th AHC Memorial Fund

1. Name: The Name of the Corporation is: **The 57th AHC Memorial Fund**
2. Purpose: The purpose for which the corporation is organized is: To build a memorial in honor of the members of the 57th Assault Helicopter Company (AHC) which served in Vietnam from 1967 to 1973.
3. Character of Affairs: To build a memorial in honor of the members of the 57th AHC which served in Vietnam from 1967 to 1973.
4. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
5. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements,) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal income Tax under Section 501 (c)(3) of the United States Internal Revenue Code (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions by which are deductible under Section 501 (c)(3) of the United States Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue Laws).
6. Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all its assets exclusively for the purposes of the corporation in such manner, or to such organization organized and operated exclusively for charitable, education, religious, or scientific purpose as shall at the time qualify as an exempt organization or organizations under Section 501 (c)(3) of the United States Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue Laws) as the Board of Directors shall determine. Any such assets not disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located, exclusively for such purpose or to such organization or

organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.

7. The power of indemnification under the Arizona Revised Statutes shall not be denied or limited by the bylaws.
8. Board of Directors: The initial board of directors shall consist of 3 directors. The names and addresses of the persons who are to serve as the directors until the first annual meeting of the members, if a member corporation, or board of directors if the corporation has no members, or until their successors are elected and qualifies are:




All powers, duties and responsibilities of the incorporators shall cease at the time of delivery of Articles of Incorporation to the Arizona Corporation Commission.
